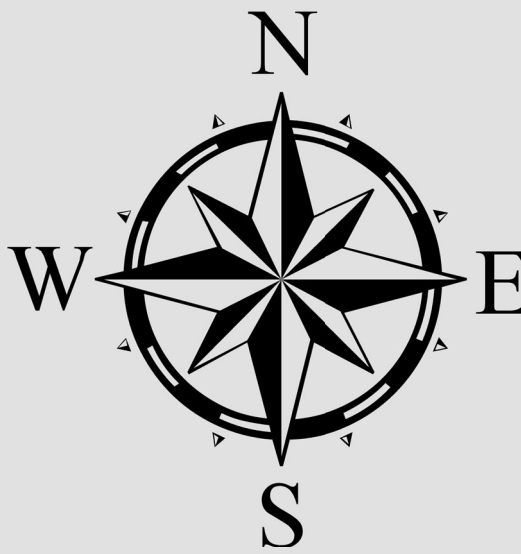

The Polling Place for Precinct 336 is Calvary Baptist Church at 4606 Lake Margaret Drive.

Precinct 336 (2024) northern boundary follows a section of East Grant Street and then follows along East Michigan Street. The western boundary follows Conway Road. The southern boundary follows Anderson Road and extends to Lake Margaret Drive. The eastern boundary follows parallel east of South Semoran Boulevard.
