

The City of Eatonville District in Orange County, Florida contains Municipal Precinct EA26 (9110).

Municipal precinct EA26 is situated north along the southern boundary of Lake Lovely, through Lake Shadow and Lake Hungerford, east along South Lake Sybelia Drive, south through Lake Bell to the northern boundary of Lake Weston, and west along Forest City Road.

This municipal precinct also includes the following Orange County precincts:
