| APOPKA 407-703-1704 | 32 square ft. maximum size. | Six square ft. maximum size. | Shall not place any political sign on any public property or right-of-way nor on any private property without the express permission of the owner or as may be allowed at public polls. | After qualifying and remove w/i 7 days after election. |
| BELLE ISLE 407-851-7730 | Non-illuminated and shall not exceed 32sqft. No larger than 4sqft in area or located within 40ft of any other sign. Any sign larger than 4ft shall be approved by City Manager prior to installation. | Two-non-illuminated, not more than 4ft, no more than 4sqft in area. May be installed w/consent of occupant or owner of property. | Shall be removed no later than 48 hours after close of election. Campaign signs shall not be placed on public property-will be removed by city officer. | May not be erected more than 90 days before date of election |
| EATONVILLE 407-623-1313 | Car top signs. Application, with written permission of the car owner, is made. Signs are stamped or lettered with indelible ink or other permanent method. | Four square ft. maximum size. | \$50 bond may be required; refunded or used by city for removal of signs. | 30 days prior to 14 days after election. |
| EDGEWOOD 407-851-2920 | Three signs up to six square feet each in copy area up to three feet in height. Temporary signs must be at least five feet from any right-of-way and at least ten feet from the side and rear property lines | Two temporary freestanding signs no greater than six square feet in copy area with sign height no greater than three feet shall be allowed on the premises | Signs shall not be illuminated | Beginning 60 days prior to any local, state or federal election and lasting until three days after such election. |
| MAITLAND 407-539-6219 | Shall not exceed 32 square ft. in sign area; and, if displayed as freestanding on the parcel, shall not exceed 12 ft. in height. | Shall not exceed six (6) square ft. in sign area; and, if displayed as a freestanding on the parcel, shall not exceed four (4) ft. in height. | Signs are <u>not</u> subject to permits or fees. For each parcel, one on-site for each candidate and each issue may be displayed along each public street abutting the premises but shall not be placed in the right-of-way. | 82 days prior and removed w/in seven (7) calendar days following the election to which it pertains. |
| OAKLAND 407-656-1117 | 32 square ft. maximum size, per parcel, per endorsed candidate. | 16 square ft. maximum size, per parcel, per endorsed candidate. | Eight ft. maximum height. Political signs shall not be placed on any public property or public right-of-way or on private property without owner's written permission. | 60 days prior to 7 days after election. |

| OCOE 407-905-3100 | 32 square ft. maximum size non-illuminated. No sign exceeding 4 square ft. to be w/i 40 ft. of any other campaign sign. Signs larger than 4 square ft. require permit/approval. | Two signs - 4 square ft. maximum size. Campaign signs are prohibited on vacant property. | Prohibited on public property and in the right-of-way. Illuminated signs are prohibited. | Remove w/i 48 hrs. after election. |
| ORANGE COUNTY 407-836-3111 | 32 square ft. maximum size per parcel. | 16 square ft. maximum size. | Maximum height of any political sign is 8 ft. Not allowed on right-of-ways. | 90 days prior to 10 days after election. |
| ORLANDO 407-246-2686 | 32 square ft. maximum size. | Two signs - 4 square ft. maximum size. | Permits may be required. Signs are prohibited on public property and in the right-of-way. See section 64.252, Orlando City Code, for more information. | Remove w/i 48 hrs. after election |
| WINDERMERE 407-876-2563 | Political and election campaign signs not exceeding four square feet in area may be displayed by an owner or tenant on their property without a permit. | Political and election campaign signs not exceeding four square feet in area may be displayed by an owner or tenant on their property without a permit. | | |
| WINTER GARDEN 407-656-4111 | 32 square ft. maximum size. | 8 square ft. maximum size. | City Code Board may assess fines for each sign not removed within 10 days. Campaign signs not permitted on public property. | Remove w/i 10 days after election. |
| WINTER PARK 407-599-3600 | One sign on any one property frontage, per street frontage - 2 square ft. maximum size. | One sign on any one property per street frontage - 2 square ft. maximum size. | Must be located behind sidewalk or 10 ft. behind curb if no sidewalk is present. Banner & wind signs are prohibited. Tacking, pasting or affixing signs to building walls, trees, utility poles, posts, fences or other structures is prohibited. | Not earlier than 45 days prior to and w/i 3 days after election. |
