

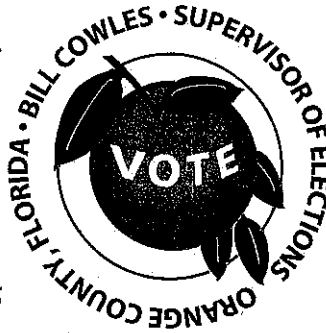



Records in this office indicate that you were sent a financial disclosure packet and advised of the July 1 deadline for filing Form 1, Statement of Financial Interests, on or about May 31, 2016. As of this time, however, there is no record of your having filed a Form 1 with this office.

Please note that persons serving as of December 31, 2015 (along with officials elected in 2015 whose terms began in January of 2016 are required to file this year). **PLEASE NOTE EVEN IF YOU LEFT THE POSITION NOTED ON THE MAILING LABEL DURING 2016, YOU ARE REQUIRED TO FILE DISCLOSURE FOR 2015.**

Pursuant to State law, I am writing to notify you that although you are delinquent in filing Form 1, a grace period is in effect until September 1, 2016. If your Form 1 is not received by September 1, 2016, I will be required by law to notify the Commission on Ethics of the delinquency and a fine of \$25 for each day late will be imposed, up to a maximum penalty of \$1500. In addition, pursuant to recently enacted legislation, the Commission on Ethics must initiate investigations of delinquent filers in certain circumstances. This can result in your being removed from your public office or employment. See Section 112.3145(8)(c), Florida Statutes.

If you have misplaced the disclosure form, please contact this office. However, if you have any questions concerning the completion of or your obligation to file a disclosure statement, you must contact the Commission on Ethics at (850) 488-7864, or by writing to Post Office Drawer 15709, Tallahassee, FL 32317-5709. However, please do not file the Form 1 with the Commission on Ethics.
