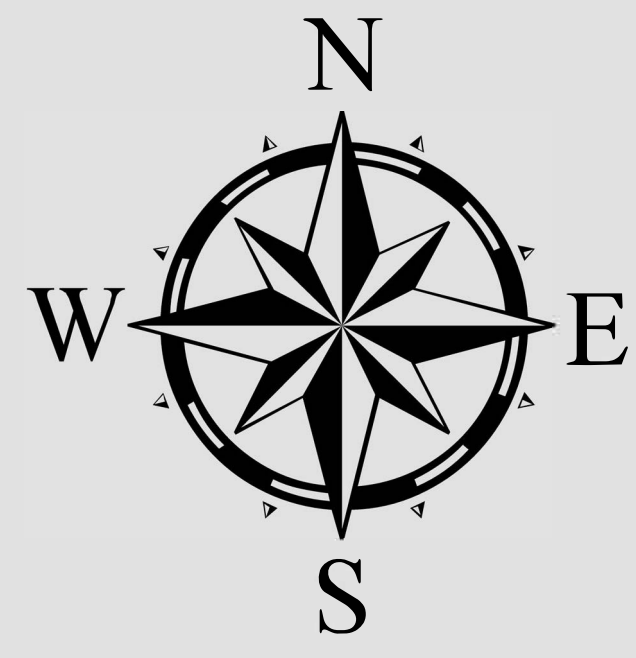

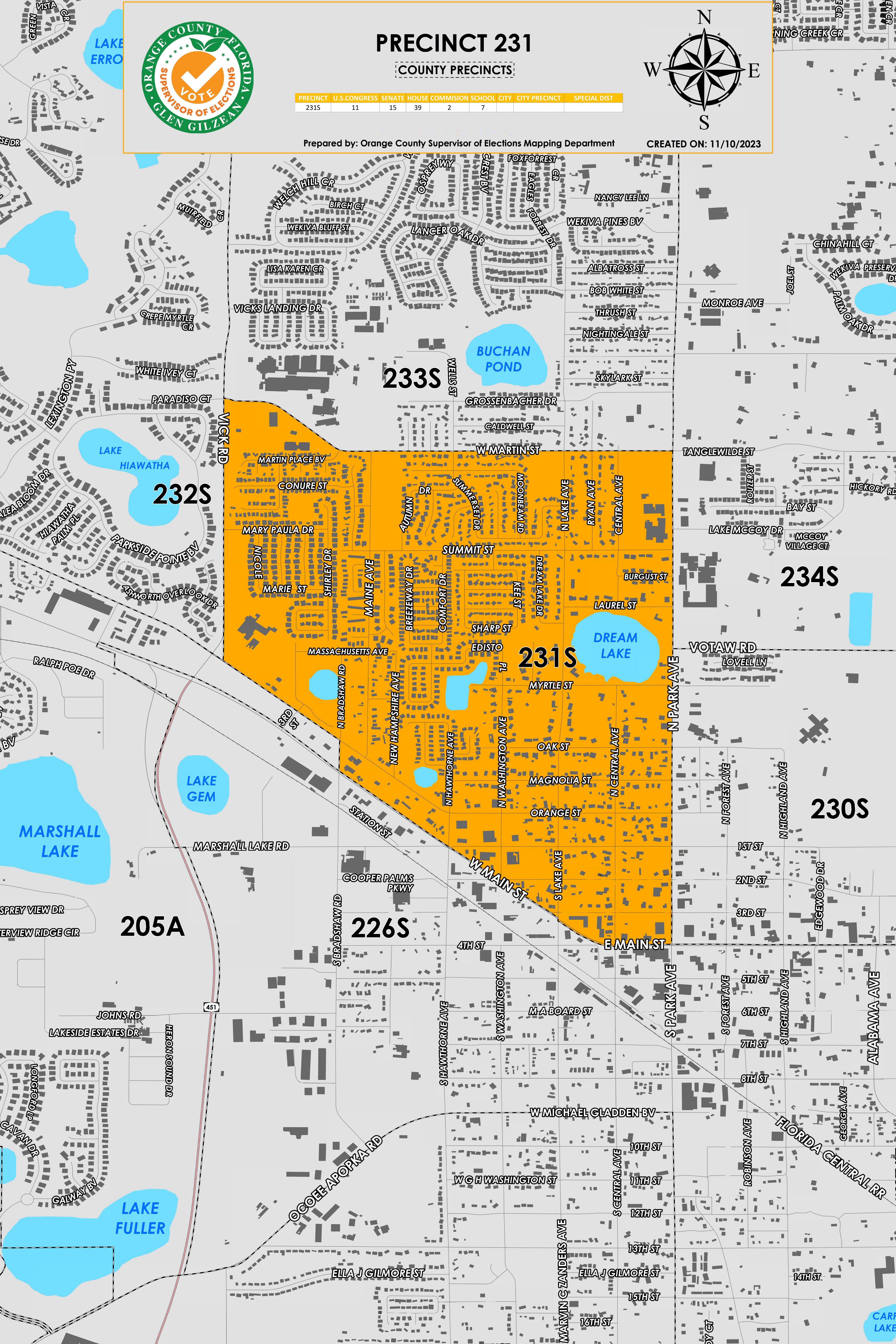

Precinct 231 (2024) northern boundary follows along Martin Street, the western boundary follows along Vick Road, the southern boundary follows along Old Dixie Highway then continues onto West Orange Blossom Trail and Main Street. The eastern boundary follows along North Park Avenue.

Precinct 231S is with district assignments of U.S. Congress 11, State Senate 15, State House 39, County Commission 2, and School Board 7.
